The Rev. Walden M. Holl, DD Award was established by Allegheny Lutheran Social Ministries in 1999 in memory of Dr. Holl, who served as Executive Director of the agency from 1975 until his retirement in 1978. Ordained in 1937, Dr. Holl admirably served three congregations during his ministry, the last being First Lutheran Church in Johnstown, where he was the Senior Pastor for 31 years before accepting the ALSM position. A capable leader, a sensitive pastor, an insightful teacher, an outstanding preacher, and an ardent advocate of the downtrodden, Dr. Holl brought to ALSM his vision of "...serving people in Christ's Name..." ALSM grants this award annually in recognition of a Rostered Leader of the Allegheny Synod, Evangelical Lutheran Church in America, who has demonstrated by exceptional attitude and action the noble attributes of one living out the indicatives of Micah 6:8 and that were exemplified in the ministry of Dr. Holl.
